- Set MH 222 moving north from Anderson.
- o Began Keene Creek Crossing 2.
- Subcutting for trail at Stebner Park. Subcutting complete from 188+00 to 165+00.
- o Set culvert along Stebner Park Drive, construction trail base along Stebner Park Drive.

Schedule

- USA to continue working north of Anderson from MH-222. Plan is to continue north as dry conditions allow.
- Keene Creek Crossing 2 to begin.
- Trail work to continue east from Stebner Park.

- Blasting operation to continue.
