2) Meeting Summary

- Progress
 - USA was about 250' out of MH-229 when pipe elevation raised above the design elevation. NCE directed USA to remove run starting a MH-229 an construct at plan grades. Pipe crews to be on hold until cooler temps drive some frost in the ground and blasting crew is complete.
 - South Pond is about 90% completed. Touch up and stabilization will likely fall to next year.
- <u>Schedule (all weather permitting at this point)</u>
 - Sewer work to continue to north with focus on rock blasting the remaining length. Pipe progress likely slow for the next couple weeks.
 - Blasting operations to continue.
 - Second crew on site and set MH-231 near Maple Grove.
 - o Pond excavation to continue at public works facility.
- Other Discussion Items
 - USA submitted updated schedule and extension request. This will be Change Order #4.
 NCE noted that trail from park to Hermantown Rd. shall be completed by 6/30/20. NCE to prepare CO #4.
 - USA directed to place rock at entrances to the trail. Coordinate with NCE prior to placement. (Okerstrom, Stebner Park, and both sides of Anderson)
 - o MERC and MP have relocated their lines in the Maple Grove ROW.
 - o Century Link and NESC have not responded to requests to submit plans.
 - Added catch basin and pipe to improve drainage conditions at the public works facility. NCE to develop sketch for USA pricing.
 - City asked USA to look into cleaning pipe using Great Lakes Pipe using tracked equipment to attempt to take lift station off line a soon as possible. USA to present added costs of this service.

 - Pay Estimate and CO #4 will be presented at December 7th CC meeting.
