2) Meeting Summary

Progress

 Maintenance Trail sand and C5 completed to Maple Grove Road. All culverts installed along that stretch. USA continuing slope shaping and cleanup in that area.

Schedule

- USA to continue slope refinement of maintenance road construction from "tee" to Maple Grove.
- USA to jump to trail segment south of Anderson to complete last segment of trail base.
- Verify catch basin casting at public works.
- o USA to grade laydown area near Stebner Park and continue placing rocks around the perimeter.
- NCE to developing punch list for project.
- NCE and USA to discuss trail along Maple Grove and potential utility impacts.

Other Discussion Items

- o June 30th trail completion date from Stebner Park to Engwalls
- Paving plan and tentative schedule
 - City asked that USA bring paving subcontractor to construction meeting and walk site at least a week ahead of time to discuss process.
- USA and NCE to verify elevation of culvert D-129. Likely needs to be lowered.
- Culvert D-120 is damaged and needs to be addressed.
- o Reminder to implement SWPPP stabilization in accordance with NPDES Permit.
- Next Pay App will be for work completed thru 5/29/21 and brought to June 7th CC Meeting.
- USA and NCE to test pit C5 elevations.
- Discussed wetland restoration and placement of topsoil in these areas to promote vegetation growth.
- Trail adjustment along Maple Grove Road to avoid utilities.
 - MP guy wire to be adjusted (Aaron Nelson confirmed)
 - Century Link pole to be removed or replace out of the way. (Mike Coughlin confirmed)
