4. WORK SESSION (Project Updates)

A. Update and Overview of HEDA Activities: John Mulder explained the various HEDA's bylaws and the various actions HEDA should take as part of their annual meeting. The July meeting has been the annual meeting to coincide with the audit being completed by the City's auditors and the preparation of the budget for the next year. John reminded the group that they have been focusing on three major areas for development in the past year: the Stebner Farm, Hwy 53 Business Park, and the Engwall's site. HEDA was also supporting some the marketing efforts of Hermantown's Home Town campaign.

B. Overview and Discussion on Tax Increment Financing Planning: John Mulder explained the development plan that was established in 1993. The development district had generally included land east of Ugstad and north of Maple Grove and south of Maple Grove to approximately Oak Ridge Drive on the east side of Stebner. In order to create a Tax Increment Financing District, property had to be within that development district. In order to allow TIF District on Engwall's site, the Development District needed to be expanded. Staff recommended to include all land east of Ugstad and include Section 4 & 5 along Hwy 53. HEDA discussed the proposed Development district and choose to modify it to include a corridor along Hwy 2, but eliminate east of Ugstad south of Maple Grove and land south of Morris Thomas. Staff was directed to modify the map for the notice of the public hearing.
