During the week of 10/01/23 to 10/07/23, the Hermantown PD had 172 calls. The following are selected incidents HPD responded to this week.

DWI

On 10/2/23 at 2351 hours, Hermantown officers were on routine patrol in a fully marked squad car driving through the area of Hermantown and Haines Road when they observed a truck parked at the Korner Store. Officers were aware that the store was closed and the truck did not appear to be an employee's vehicle. Officers observed a male in the driver's seat of the truck.

Officers approached the truck and observed the male's head was slumped over and his eyes were closed. Officers knocked on the window of the vehicle and loudly announced it was the police department. The male woke for a moment, but he proceeded to close his eyes again and did not respond. After a minute and a half of knocking on the vehicle's window, the driver eventually woke and opened the door. When the 33-year-old male then opened the door, officers noted they immediately observed an odor of alcohol emitting from inside the vehicle. When asked how much alcohol he consumed that night and he stated "a lot." The male agreed to do standard field sobriety testing. He provided a PBT sample of .23 BRAC. The man was ultimately charged with 3rd Degree DWI.

Accident

On October 3, 2023 at 1538 hours, dispatch notified officers that they received a notice from a phone application that the user may have been involved in a crash as it sensed irregular movement and they were not able to contact the party. Squads arrived on scene and located the attached vehicle in the weeds off the end of Lightning Drive. A 16-year-old male was on scene and identified himself as the driver of the vehicle. The male said he lost control going around the corner and ended up in the weeds 20-30 yards past the end of the road. Officers noticed skid marks on the gravel road on Lightning Drive leading up to where the vehicle went off the road.

There were also two passengers in the vehicle, who stated the driver was going too fast and told officers that the driver was trying to drift the corner. A nearby homeowner of the accident also explained to officers that the vehicle narrowly missed running over her dog when he went off the road and that she has seen this same vehicle drift that corner multiple times in the past. The male was issued a tag for City Ordinance Exhibition Driving and Provisional License Violation for having two passengers in the vehicle during the first six months of having a license.

Disturbance

On October 3, 2023 at 1755 hours, dispatch received a call of a male acting erratic outside of Dairy Queen, holding an axe and making people nervous. Officers arrived and a male matching the reported description was standing on the outside patio holding multiple items. Due to the report of the male armed with an axe in a public place, he was detained him in cuffs for everyone's safety and

the male lightly resisted. Officers then patted the 48-year-old male down and found a small axe in his left front pants pocket.

Officers reviewed video and it appeared that the man was walking both inside and outside of restaurant and at times holding the axe in his hand. Hit & Run

Officers were able to locate the suspect at the nearby Dairy Queen due to the description they received from dispatch. Officers questioned the 31-year-old woman about the theft. She admitted that she had tried to steal clothing from the store. She also said that she had stolen some paper towels and then went and returned them at the service desk for money.

Through further investigation, the store was able to learn that the woman had actually stolen closer to \$200 worth of merchandise. The woman was ultimately charged with Shoplifting and was also trespassed from the store.
