Great Northern Sports Dome is excited to work with the City of Hermantown, MN ("the City") on the proposed sports dome ("the Project") in Hermantown, MN on the +/-9.2 acre property located within Stebner Park. Great Northern Sports Dome understands that the exact acreage and location will be determined at a future date and identified with a survey and legal description, to be prepared by the City as well as results from soil borings provided by Great Northern Sports Dome.

It is our understanding that the intention of the parties is to proceed in accordance with the construction of a 100,000 square foot dome, atrium entrance building (with locker rooms, meeting rooms, and rentable space to compliment the dome patrons), parking lot, site improvements, creation of soccer fields and stormwater facilities associated with the Project. Neither the City nor the Hermantown Economic Development Authority ("HEDA") can be obligated regarding land conveyance associated with the Project unless contract(s) creating obligation(s) is/are approved by the Hermantown City Council and/or the Hermantown Economic Development Authority and the contract(s) is/are in compliance with all applicable laws.

This letter is an expression of our mutual intention only and does not constitute a binding agreement among the parties with respect to the Project. Any such binding agreement would only arise as a result of negotiation, execution, and delivery of final written contract(s) having terms and conditions satisfactory to all included parties.

- Great Northern Sports Dome, the City and HEDA shall work and negotiate to arrive at mutually acceptable final written contract(s) at the earliest reasonably practical date allowed.
- 2. The City may not incur any obligations to pay any costs until and unless a contract creating obligations is approved by the Hermantown City Council and/or the Hermantown Economic Development Authority and the contract is in compliance with all applicable laws.
- 3. Any party may terminate this Letter of Intent, at its own discretion, upon two (2) weeks' written notice provided to all other parties.
- 4. The Hermantown City Administrator, who is signing this Letter of Intent, does not have the authority to legally bind the City. His execution of this is to reflect that the City administrative staff will proceed as set forth in this letter.
