Paul Senst - Water Testing-Water Testing for Dept of Health. Testing changing as of April 1, We will now be doing the testing not Duluth. We will be hiring PACE 8 testing sites per month. We collect samples send it to them and they will provide them to the state. It will be around + \$12,000/yr.

Eric Johnson - Community Development- Comprehensive plan presentation pg 50, Land Use focused on the Adolph expansion of the urban service area because of the power company, railroad, major truck Route. MN Power owns 320 acres on 14 parcels in this area. Pg 80-81 Utilities expansion map, comments before April 15 (7:00pm). Jim add UC to acknowledgments.

David Bolf -City Engineer

Lift station on Lavaque/Thompson runs at about 20% but can do more and NCE is looking at options extending that 4 m miles of sewer. Showed the several water options for – third option with booster pump, a reservoir, and some pressure at Midway and 53-12 miles of water. Doug asked would this be phased-David said yes. Build water boosters and regulators first, then tower, then sanitary. Jim asked why not Morris Thomas – David because we don't have the drop and it would not benefit the rest of the city. We also thought it would be good practice to have 2 days of water stored Andy asked about cost-David said probably \$100 million.

Duluth Water Infrastructure Surcharge - Additional Option

Jim stated this is not going away. Rob stated that the small commercial businesses are going to take a hit and that may change interest with the city, for new businesses to come. Commission decided to keep the prior option of a flat \$7.50 per customer flat fee across the board.
